

PRIVACY POLICY AND DATA PROTECTION NOTICE

Effective Date: November 5, 2024

Inmigración Latam Plus LLC ((hereinafter "we," "us," or "our") operates the website http://www.inmigracionlatamplus.com/ (the "Service").

This Privacy Policy and Data Protection Notice provides mandatory information in accordance with U.S. data protection laws.

This page informs you about our policies regarding the collection, use, and disclosure of personal data when users (hereinafter "you," "your," or "yours") use our Service, as well as the choices you have regarding that data. Unless otherwise defined in this Privacy Policy, the terms used herein have the same meanings as in our Terms and Conditions, available at http://www.inmigracionlatamplus.com/.

1. Definitions

1.1 Personal Data

Personal Data refers to information about a living individual who can be identified by that information (or by that information combined with other information in our possession or likely to come into our possession).

1.2 Usage Data

Usage Data refers to data collected automatically, either generated by the use of the Service or by the Service's infrastructure itself (for example, the duration of a visit to a webpage).

1.3 Cookies

Cookies are small pieces of data stored on a user's device.

1.4 Data Controller

The Data Controller is a person who (either alone, jointly, or in common with other persons) determines the purposes for which and the way in which any personal data is processed.

1.5 Data Processor (or Service Provider)

A Data Processor (or Service Provider) refers to any person (other than an employee of the Data Controller) who processes data on behalf of the Data Controller.

We may use the services of various Service Providers to process your data more efficiently.

1.6 Data Subject

A Data Subject is any living individual who is the subject of Personal Data.

1.7 User

The User is the person who uses our Service. The User corresponds to the Data Subject, who is the subject of the Personal Data.

2. Collecting Information and Processing Your Data

We collect different types of information for various purposes to provide and improve our Service.

2.1 Types of Data Collected

2.1.1 Personal Data

While using our Service, we may ask you to provide certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, for example:

Email address
First and last name
Phone number
Address, state, province, ZIP/postal code, city
Banking information
Affiliated organizations



Cookies and Usage Data

2.1.2 Usage Data

We may also collect information about how the Service is accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (your IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, your time spent on those pages, unique device identifiers, and other diagnostic data.

2.1.3 Location Data

We may use and store information about your location if you give us permission to do so ("Location Data"). We use this data to provide features of our Service and to improve and customize our Service.

You may enable or disable location services at any time while using our Service through your device settings.

2.1.4 Tracking Data and Cookies

We use cookies and similar tracking technologies to track activity on our Service and to store certain information.

Cookies are files containing small amounts of data that may include an anonymous unique identifier. Cookies are sent by a website to your browser and stored on your device. Other tracking technologies used include beacons, tags, and scripts to collect and track information and to improve and analyze our service.

You can set your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you choose not to accept cookies, you may not be able to use some parts of our service.

Examples of cookies we use:

Security cookies. We use security cookies for security-related purposes.

2.2 Data Uses

Inmigración Latam Plus LLC usa los datos recogidos para diversos propósitos:

To provide and maintain our service;

To notify you about changes to our service;

To allow you to participate in interactive features of our service when you choose to do so;

To provide customer support;

To collect analytics or valuable information to help us improve our service;

To monitor usage of our service;

To provide you with news, special offers, and general information about other goods, services, and events we offer that are similar to those you have already purchased or inquired about, unless you have opted out of receiving such information

Inmigración Latam Plus LLC may store and use your data to share with you new products, company news, events, and sales quotes. You will only receive emails if you have specifically opted in to receive them, and you can opt out of receiving some or all of the communications we send by following the unsubscribe link or the instructions provided in any email we send or by contacting our data controller.

2.3 Processing of Minors Data

Due to the nature of the services provided, we may occasionally need to collect information from minors under the age of 18, the processing of which will only be lawful if, and to the extent that, the holder of parental responsibility for the minor provides their consent or authorization.

2.4 Data Retention

Some personal data will only be retained for as long as necessary for the purposes set out in this Privacy Policy and Data Protection Notice.

We will retain and use your personal information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our legal agreements and policies.

Inmigración Latam Plus LLC will also retain usage data for internal analysis purposes. Usage data is generally retained for a short period, unless it is used to enhance the security or functionality of our service, or we are legally required to retain such data for a longer period.



2.5 Transfer of Your Data

Your information, including personal data, may be transferred to and stored on computers located outside your state, province, country, or other governmental jurisdiction where data protection laws may differ from those in your jurisdiction. Where possible, we will only transfer data to countries that have ratified the Council of Europe Convention of January 28, 1981, for the Protection of Individuals regarding Automatic Processing of Personal Data.

Inmigración Latam Plus LLC will take all reasonable steps to ensure that your data is treated securely and in accordance with this Privacy Policy and Data Protection Notice, and no transfer of your personal data to any organization or country will occur unless adequate controls are implemented, including the security of your data and other personal information.

2.6 Disclosure of Your Data

2.6.1 Disclosure for Law Enforcement Purposes

In certain circumstances, Inmigración Latam Plus LLCmay be required to disclose your personal data if required to do so by law or in response to valid requests from public authorities (a court or government agency).

2.6.2 Legal Requirements

Inmigración Latam Plus LLC may disclose your personal data with a good faith belief that such action is necessary to:

Comply with a legal obligation;

Protect and defend the rights or property of Immigration Latam Plus LLC;

Prevent or investigate possible misconduct in connection with the service;

Protect the personal safety of users of the service or the public;

Protect against legal liability.

2.7 Security of Your Data

We have implemented a data protection system to oversee the effective and secure processing of your personal data.

To prevent unauthorized access or disclosure, we have put in place appropriate physical, electronic, and managerial procedures to safeguard your personal data.

The security of your data is important to us, but please be aware that no method of transmission over the internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your personal data, we cannot guarantee its absolute security.

3. Your Rights

3.1 Access to Your Personal Data

Inmigración Latam Plus LLC will take reasonable steps to allow you to correct, amend, delete, or limit the use of your personal data.

Unless you are subject to an exception under U.S. law, you have the following rights regarding your personal data:

Access and receive a copy of the personal data we hold about you in a commonly used electronic format;

Correct any personal data we hold about you that is inaccurate or outdated;

Request the deletion of personal data we hold about you;

Request that the data controller, where possible, transmit the data directly to another data controller;

The right, when there is a dispute about the accuracy or processing of your personal data, to request a restriction on future processing;

Unsubscribe from receiving future emails.

To exercise any of these rights, please contact our data controller directly.

Where possible, you can update your personal data directly in the settings section of your account.

Please note that we may ask you to verify your identity before responding to such requests.

We do not charge for this service, and your request will be processed within 7 business days from the date we receive it, and in no case later than one month. This period may be extended for a further two months if necessary, considering the complexity and volume of requests.

3.2 Withdrawal of Consent

You have the right to withdraw your consent at any time, but this will not affect the lawfulness of the processing based on the consent before it was withdrawn.



3.3 Right to Lodge a Complaint with a Data Protection Authority

If you are not satisfied with our response, or if you believe we have processed your personal data in a way that does not comply with the law, you have the right to lodge a complaint directly with a supervisory authority in your country.

3.4 Personal Data Breaches and Notification

In the event of a personal data breach, our data controller must notify the affected data subject within 72 hours of discovering the breach, unless one of the following three exceptions applies:

The breach is unlikely to result in a high risk to the rights and freedoms of the data subjects;

Technical and organizational safeguards were in place at the time of the incident (e.g., encrypted data);

It would trigger disproportionate measures (instead, a public information campaign or "similar measures" should be used to effectively inform the affected individuals).

4. Service Providers and Analytics

We may employ third-party companies and individuals to facilitate our Service ("Service Providers"), to provide the Service on our behalf, to perform services related to the Service, or to assist us in analyzing how our Service is used.

These third parties have access to your personal data only to perform these functions on our behalf and are required not to disclose or use it for any other purpose. Your personal data will only be processed by authorized personnel.

We may use third-party service providers to monitor and analyze the use of our Service.

5. Do Not Track Messages

We do not support Do Not Track. Do Not Track is a preference you can set in your web browser to inform websites that you do not wish to be tracked.

You can enable or disable the Do Not Track preference by visiting your browser's preferences or settings page.

6. Links to Other Sites

Our Service may contain links to other sites that are not operated by us. If you click on a third-party link, you will be directed to that third-party's site. If we wish to use your personal data for a new purpose not covered by this Privacy Policy and Data Protection Notice, we will provide you with a new notice explaining the new use and outlining the relevant purposes and conditions of processing before we begin processing.
